AVERAGE DEBT BURDEN ON FARMERS

Will the Minister of AGRICULTURE & FARMERS WELFARE be pleased to state:

- (a) whether average debt on farmer families has increased in the country during last five years;
- (b) if so, the details thereof and the reasons therefor;
- (c) the current debt on the farmers in the country, State-wise including Uttar Pradesh;
- (d) whether any scheme is currently proposed to provide relief to the farmers from debt;
- (e) if so, the details thereof and if not, the reasons therefor; and
- (f) the details of the average income of agricultural and daily wage labourers in the country, Statewise and the details of rise in their income during said period, year-wise?

- (a) & (b): National Statistical Office (NSO), Ministry of Statistics and Programme Implementation (MoSPI) conducted a Situation Assessment Survey (SAS) of Agricultural Households during NSS 77th round (January 2019- December 2019) with reference to the agricultural year July 2018- June 2019 in the rural areas of the country. Similar survey was also conducted during 70th round by NSO. As per the result of 77th round of survey, the average amount (Rs.) of outstanding loan per agricultural household is Rs 74,121 for the year 2018-19.
- (c): The State-wise (including Uttar Pradesh) average amount of outstanding loan (debt) per agriculture household in the country is given at **Annexure-I.**
- (d) & (e): The Government of India had implemented Agricultural Debt Waiver and Debt Relief Scheme (ADWDRS) in 2008-09. After the closure of ADWDR, 2008, no other waiver scheme has been implemented by the Union Government. However, The Government of India, has inter-alia, taken the following major initiatives to reduce the debt burden of farmers and thus freeing them from the clutches of money lenders. These schemes/initiatives include KCC

Saturation drive to ensure concessional institutional credit to all eligible farmers in the country, income support of Rs.6000 per year to farm families in 3 equal instalment through Pradhan Mantri Kisan Samman Nidhi (PMKISAN), Pradhan Mantri Fasal Bima Yojana (PMFBY), formation of Joint Liabilities Groups (JLG's), Rashtriya Krishi Vikas Yojana (RKVY), National Food Security Mission (NFSM), National Agriculture Market (e-NAM), National Mission For Sustainable Agriculture (NMSA), Pradhan Mantri Kisan Maan-Dhan Yojana (PM-KMY) etc.

(f): The state-wise average monthly income (Rs.) from different sources income includes income from wages, income from leasing out of land, net receipt from crop production, net receipt from farming of animals and net receipt from non-farm business per agricultural household during agricultural year July 2018 - June 2019 is at **Annexure-II**
