NEGLIGENCE IN PAYMENT TO SUGARCANE GROWING FARMERS

1992 # SHRI RAM NATH THAKUR:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) whether it is a fact that States have been empowered to make legislations on payment for sugarcane to the farmers, fixing its price and its procurement;
- (b) whether experts have pointed neglect of interests of sugarcane farmers therein, who are facing non-payment of their produce;
- (c) whether sugarcane growing farmers are getting payment at different rates in different States;
- (d) if so, details of rates of payment, State-wise; and
- (e) the details of hikes in the price of sugarcane during the last five years?

A N S W E R MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

- (a): The Central Government fixes the Fair and Remunerative Price (FRP) of sugarcane for every sugar season (October-September) on the recommendations of the Commission for Agricultural Costs and Prices (CACP). However, some State Governments namely Uttar Pradesh, Uttarakhand, Punjab & Haryana fix the State Advised Price (SAP) for sugarcane, which is higher than the FRP.
- (b): No, Sir. As on 16.12.2022, more than 99% of cane dues upto sugar seasons 2020-21 have been cleared. In respect of sugar season 2021-22, about 98% of cane dues have been cleared.

- (c) & (d): FRP of sugarcane for current sugar season 2022-23 (Oct- Sep) has been fixed at ₹ 305/quintal for a basic recovery rate of 10.25%, providing a premium of Rs. 3.05/quintal for each 0.1% increase in recovery over and above 10.25%, & reduction in FRP by Rs. 3.05/quintal for every 0.1% decrease in recovery till 9.5% recovery rate. In case of sugar mills where recovery is below 9.5%, such farmers get Rs. 282.125/quintal for sugarcane. The FRP of sugarcane is the benchmark price below which no sugar factory can purchase sugarcane from farmers. However, some states namely Punjab, Haryana, Uttar Pradesh & Uttarakhand fix State Advised Price (SAP) for sugarcane. So far, only one state namely Punjab has announced the State Advised Price of Rs. 380/quintal for current sugar season 2022-23. State Advised Price of Haryana, Uttar Pradesh & Uttarakhand for Sugar season 2021-22 were Rs. 362/quintal, Rs. 350/quintal & Rs. 355/quintal respectively.
- (e): A statement having details of hikes in FRP of sugarcane during the last five years is at Annexure.
