MEASURES AGAINST LUMPY SKIN DISEASE

2017 SHRI MOHAMMED NADIMUL HAQUE:

Will the Minister of FISHERIES, ANIMAL HUSBANDRY & DAIRYING be pleased to state:

- (a) the number of vaccines given to the States for vaccinating cattle against Lumpy Skin Disease (LSD), State-wise;
- (b) the number of cattles which have died from the disease, State-wise;
- (c) the number of practising Government veterinary doctors, State-wise;
- (d) whether Government has conducted any survey of the damage caused to A2 cows due to LSD in the country and if so, details thereof; and
- (e) whether Government has conducted any study on the unintended consequences of the vaccine to cattles in the long run and if so, the details thereof?

ANSWER

THE MINISTER OF FISHERIES ANIMAL HUSBANDRY AND DAIRYING (SHRI PARSHOTTAM RUPALA)

- (a) and (b): Animal Husbandry is a State subject. However, Department of Animal Husbandry and Dairying, Government of India is taking all necessary steps to support States / UTs to control and contain Lumpy Skin Disease (LSD) which include financial and technical support. The guidelines/advisories for control of LSD including vaccination have been circulated to States / UTs for implementation so as to control and contain the disease within a definite timeline. Further, as gathered from the states, vaccination against LSD is underway in the affected States/UTs. As gathered from the States/UTs, the state-wise details regarding number of death of cattle and vaccination done is attached as **Annexure 1.**
- (c): As gathered from States/ UTs, the state-wise details of practicing Government Veterinary doctors are attached as **Annexure 2**.
- (d): As gathered from the States/UTs and Indian Council of Agricultural Research (ICAR), no survey of the damage caused to A2 cows due to LSD in the country has been conducted. However, the guidelines/advisories for control of LSD including vaccination have been circulated to States / UTs for implementation so as to control and contain the disease within a definite timeline
- (e): Presently, the vaccination against Lumpy Skin Disease (LSD) with available Goat Pox Vaccine is underway. As gathered from the States/UTs, no unintended consequences of the vaccine to cattle have been reported.
