BENEFITS TO THE FARMERS THROUGH PMKSY

2033. SHRI SANJAY RAUT:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) whether Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) was launched with a view to benefit the farmers;
- (b) if so, the extent to which the farmers have actually been benefitted since the launch of the scheme;
- (c) the details of proposals received so far from various State Governments and entrepreneurs for setting up of food processing units under PMKSY and the action taken by the Union Government thereto; and
- (d) whether the Union Government has approved the proposals under the scheme for creation of Infrastructure for Agro-Processing Clusters of PMKSY, if so, the details thereof, State-wise?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

- (a) & (b): The Ministry of Food Processing Industries (MoFPI) has been implementing an umbrella scheme Pradhan Mantri Kisan Sampada Yojana (PMKSY) since 2017-18 across the country. PMKSY is a comprehensive package of sub-schemes, which aims at creation of modern infrastructure with efficient supply chain management from farm gate to retail outlet. It provides a big boost to the growth of food processing sector in the country, help in providing better prices to farmers, creating huge employment opportunities especially in the rural areas, reducing wastage of agricultural produce, increasing the processing level and enhancing the export of the processed foods. 18,06,027 farmers have been benefited so far since inception of PMKSY.
- (c): 4026 project proposals (from various State Governments and entrepreneurs) under various subschemes of PMKSY have been received during the period from 2017-18 to 2022-23. Out of these, 1002 have been approved as on 16.12.2022.
- (d): State-wise details of proposals received and approved under Scheme for Creation of Infrastructure Development for Agro Processing Cluster of PMKSY during the period from 2017-18 to 2022-23 (as on 16.12.2022) is provided at **Annexure.**
