PROPOSALS RECEIVED UNDER SWADESH DARSHAN 2.0

293. SHRI A. A. RAHIM:

Will the Minister of **TOURISM** be pleased to state:

- (a) the number of proposals Government has received under Swadesh Darshan 2.0 Scheme and the number of proposals that have been approved, the details thereof, State-wise; and
- (b) whether the Central Government has received the proposal from the State Government of Kerala under Swadesh Darshan 2.0, if so, whether the Central Government has decided to provide approval, if not, the reasons therefor?

ANSWER

(a) to (b): The Ministry of Tourism has revamped its Swadesh Darshan scheme as Swadesh Darshan scheme 2.0 (SD2.0) in order to develop sustainable and responsible tourist destinations with tourist & destination centric approach. As per the guidelines of the Swadesh Darshan 2.0, the States will prepare a State Perspective Plan (SPP) analysing tourism potential of various destinations and the Ministry will select destinations of the State for development.

As of now, 29 State Governments / Union Territory Administrations have submitted their State Perspective Plans including Kerala, on the online portal formulated by the Ministry for this purpose. The State-wise list for which State Perspective Plan has been received vis-à-vis status of destinations selected for development under SD2.0 is annexed.
