Prices of petroleum products

635 Shri Javed Ali Khan:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) the details of increase/decrease in price of petrol, diesel, PNG, ATF and CNG during August, September, October and November, 2022, item-wise, date-wise and state-wise;
- (b) the details of increase/decrease in price of crude oil in International market during August, September, October and November, 2022, date-wise;
- (c) whether prices of above items have been in accordance with the increase/decrease of rates in international market during the above said period/dates;
- (d) if so, the details thereof; and
- (e) if not, the difference therein, item-wise and date-wise?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS
(SHRI RAMESWAR TELI)

(a) to (e): Prices of petrol, diesel and Aviation Turbine Fuel (ATF) have been market determined with effect from 26.06.2010, 19.10.2014 and 1.4.2001 respectively. Since then, the Public Sector Oil Marketing Companies (OMCs) take appropriate decision on pricing of petrol, diesel and ATF in line with international product prices and other market conditions.

The details of increase/decrease in price of petrol, diesel from August, 2022 to November, 2022 are given at Annexure- I.

The monthly declared prices of Aviation Turbine Fuel (ATF) at Delhi airport for the period August 2022 to December 2022 are given at Annexure -II.

Government of India has allocated domestic gas to various City Gas Distribution (CGD) entities for CNG (Transport) and PNG (Domestic) purpose. However, retail price of CNG/PNG is determined by CGD entities after considering cost of gas procured, state taxes, tariff and other components.

The Monthly average prices of Indian Basket of Crude Oil for the period August, 2022 to November, 2022 are given below:
