Will the **Minister of HEALTH & FAMILY WELFARE** be pleased to State:

- (a) the funds allotted and disbursed under Menstrual Hygiene Scheme (MHS) across the country including Tamil Nadu;
- (b) the number of adolescent girls in both rural and urban areas who have been benefited under MHS and how many workshops have been conducted to create awareness among adolescent girls in schools about safe and hygienic menstrual health practices across the country; and
- (c) if so, the details thereof, and if not the reasons therefor?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a): Under NHM, allocations to State/UTs are made in flexible pools. Whereas, approvals under NHM are given activity wise to provide greater flexibility to States/UTs to utilize the funds as per their felt need and priorities.

In view of the above, State/UT wise Approvals towards Menstrual hygiene under NHM for F.Y. 2021-22 is placed at **Annexure** 'A'

(b) and (c): The consolidated details of the beneficiaries including rural and urban areas is placed at **Annexure 'B'**

Awareness generation among adolescent girls in schools about safe and hygienic menstrual health practices are done through the existing service delivery and health promotion mechanisms in schools. Further, 360 degree IEC/ BCC activities are carried out by the States/ UTs to create awareness among the adolescent girls and other stakeholders with the funds approved as per the proposals received in the Programme Implementation Plan (PIPs) of the respective State/ UT under National Health Mission.
