Expenditure on higher education

823 Shri Anil Desai:

Will the Minister of *Education* be pleased to state:

- (a) whether Government has surveyed or made any study about the expenditure incurred per student on the education in IIT, Medical and IIM;
- (b) whether there is any bond or obligation on the student to repay the Nation by serving the people for some years; and
- (c) if so, the details thereof and if not, the reasons therefor?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF EDUCATION

(a) So far as Indian Institutes of Technology (IITs) are concerned, as per the Report of the Sub Committee of Council constituted in pursuance of the decision taken in the 49th IIT Council meeting, the estimated average expenditure on each student in IIT system is Rs. 5.2 lakh per year. As regards MBBS courses, an Expert Group of National Medical Commission (NMC) has studied the details of fee structure of private medical colleges and deemed to be universities. The details are at **Annexure-I**. With regard to Indian Institutes of Management (IIMs), the Government of India provides Rs. 5 lakhs per student per year for the new IIMs namely, IIMs at Amritsar, Bodh Gaya, Jammu, Sambalpur, Sirmour, Nagpur and Visakhapatnam while for the remaining IIMs, the expenses are borne from the student fees and internal revenues of the IIMs.

(b) & (c) With regard to IITs and IIMs, there does not exist any bond on the student, however students are encouraged to stay and work in India by incentivizing them through schemes such as Prime Minister's Research Fellowship, under which attractive fellowship is offered to selected students to pursue their Ph. D. in Indian Universities/ Institutions. With regards to medical education, many State Governments follow bond policy.

MBBS Fee Structure of Private Medical Colleges and Deemed to be universities

Private Medical Colleges (MBBS)

- (i) Median per capita annual fee: Rs. 11.5 lakhs (variations of 500x among colleges)
- (ii) Management Quota (MQ) seats: Rs. 11.5 lakhs
- (iii) NRI Quota: About Rs. 24 lakhs
- (iv) Government Quota seats (where available): 1/6th of MQ fee

Deemed to be University (MBBS)

- (i) Median per capita annual fee:Rs. 21 lakhs (variations of 23x among universities)
- (ii) Management Quota (MQ):Rs. 21 lakhs
- (iii) NRI Quota: Rs. 31 lakhs
- (iv) Government Quota seats (Rare but where available): 1/10th of MQ fee
