USAGE OF PUBLIC ROAD TRANSPORT IN THE COUNTRY

940. SHRI AKHILESH PRASAD SINGH:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:

- (a) funds released to improve public road transport infrastructure during the last five years, yearwise details thereof:
- (b) whether Government has made any effort to increase the usage of public road transport, especially in light of the growing fuel prices;
- (c) if so, the details thereof;
- (d) if not, the reasons therefor; and
- (e) the steps taken to increase accessibility of public road transport during the last five years?

ANSWER

(a) Funds have been released to State Governments under the scheme namely "Central Assistance for Strengthening ITS in Public Transport Scheme" being administered by Ministry of Road Transport & Highways. Details are provided as under;

- (b) to (d) The Ministry of Road Transport and Highways has issued guidelines dated 23.06.2022 for the Scheme namely "Central Assistance for strengthening the ITS in Public Transport System in the Country". Financial support to State Transport Undertakings is provided under the Scheme for procurement of hardware and software components for fleet management system, electronic ticketing & fare collection system (including NCMC) and passenger information & feedback system.
- (e) Ministry of Road Transport and Highways has issued the Accessibility Guidelines for Bus terminals and Bus Stops on 29.08.2022 which covers the planning and design aspects of areas in

bus ports/bus terminals and bus stops, so that these areas can be made accessible to all. Special emphasis has been laid on ensuring ease of access for the use of these facilities by end users. The aim is to ensure seamless inclusion of Divyangjan, irrespective of their disability in the context of accessibility to any such infrastructure. Further, following is the status of accessibility in the Government owned buses under the Accessible India Campaign:
