- (b) if so, the details thereof and the progress made so far;
- (c) whether Government also gave in-principle approval for fourteen NIMZs outside DMIC; and
- (d) if so, the details on the status of each one of them?

STATEMENT REFERRED IN REPLY TO PARTS (a) TO (d) OF THE RAJYA SABHA STARRED QUESTION No. 105 FOR ANSWER ON 10.02.2023.

- (a & b): Government of India granted in-principle approval to eight Investment Regions along the Delhi Mumbai Industrial Corridor (DMIC) project as National Investment and Manufacturing Zones (NIMZs). Details of 8 DMIC NIMZs are provided in **Annexure-I**.
- (c & d): Government of India also accorded in-principle approval to the 16 NIMZs under the National Manufacturing Policy (NMP). Out of these, 04 NIMZs, namely (i) Prakasam District of Andhra Pradesh, (ii) Sangareddy (erstwhile Medak) District of Telangana, (iii) Kalinganagar, Jajpur District of Odisha and (iv) Hyderabad Pharma City NIMZ in Rangareddy District of Telangana, were accorded final approval. The details of these NIMZs are given at **Annexure-II**.
