## STATEMENT

### STATEMENT REFERRED TO IN REPLY OF PART (a) TO (b) OF THE RAJYA SABHA STARRED QUESTION NO. 107 DUE FOR ANSWER IN THE RAJYA SABHA ON 13 FEBRUARY, 2023 REGARDING “AMRUT SCHEME IN HIMACHAL PRADESH”:

(a) & (b): Atal Mission for Rejuvenation and Urban Transformation (AMRUT) aims to provide basic amenities in 500 cities such as water supply to every household & substantial improvement in sewerage & septage management. Storm water drainage, non-motorised urban transport and development of green spaces & parks are other thrust areas.

Two cities, Kullu in Kullu district and Shimla in Shimla district have been selected under AMRUT in the State of Himachal Pradesh. Details of sector-wise progress made in Himachal Pradesh is as below:

Further, 22,563 household water tap connections have been provided. 35,058 sewer connections/ coverage with septage management have been provided. Creation of sewage treatment capacity of 20.90 Million Litres per Day (MLD) is under progress. 56.42 KM drains have been constructed resulting in elimination of 244 Water Logging Points. 59.27 KM pedestrian walkways and 21,007 Sqm. of parking area have been developed. Three-acre green area has also been developed.

So far, ₹55.02 crore has been expended in completed and ongoing projects under AMRUT in Kullu city of Himachal Pradesh. Details of sector-wise progress made in AMRUT cities of Kullu and Shimla of Himachal Pradesh is placed at ANNEXURE.
