(c) whether it is a fact that, as a proportion of total approvals, utilisation has fallen from 87 per cent in financial year 2019-20 to 72 per cent in financial year 2021-22;

(d) whether it is also a fact that rate of utilisation in LPS continues to remain low; and

(e) whether Government intends to increase incentives offered to encourage institutional delivery?
