NO. 283. PROF. MANOJ KUMAR JHA:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the total number of shelter homes along with their current capacity under the Scheme of Shelters for Urban Homeless, State-wise and gender-wise;
- (b) the number of urban homeless who do not have identification proof;
- (c) the number of Shelter Management Committees in the country;
- (d) whether Government proposes to take measures to improve the quality and capacity of shelter homes under the said scheme; and
- (e) if so, the details thereof?

ANSWER THE MINISTER OF HOUSING AND URBAN AFFAIRS (SHRI HARDEEP SINGH PURI)

STATEMENT

STATEMENT REFERRED IN REPLY TO PARTS (a) to (e) OF THE RAJYA SABHA STARRED QUESTION NO. 283 FOR ANSWER ON 27.3.2023 REGARDING 'SCHEME OF SHELTERS FOR URBAN HOMELESS'

(a): State/ Union Territory (UT) Project Sanctioning Committee (PSC) is competent to approve proposals for establishment of shelters under 'Scheme of Shelters for Urban Homeless (SUH)' a component of Deendayal Antyodaya Yojana- National Urban Livelihoods Mission (DAY-NULM). The operational guidelines of SUH provide that States/ Urban Local Bodies (ULBs) may establish separate shelters also to cater the special needs such as men shelters and women shelters.

As per information given by States/ UTs, as on 28.2.2023, a total of 1,815 shelters having capacity of 1.03 lakh are functional under DAY-NULM. Of which, 272 men shelters having capacity of 14,716 and 88 women shelters having capacity of 3,832 are functional. State/UT-wise details of functional shelters and their capacity under DAY-NULM as on 28.2.2023, are at Annexure.

- (b): Mission guidelines do not prescribe the need of any identity proof to access the shelters. The shelter is a space for convergence and various entitlements of social security of the homeless. The Executive Committee of ULB headed by Municipal Commissioner is responsible to ensure availability of such entitlements including Electors' Photo Identity Card, Aadhar Card etc. as per eligibility to the urban homeless. The details of such benefits availed by individual urban homeless would be available with respective States/ UTs.
- (c): As per information given by States/ UTs, as on 28.2.2023, 1,222 Shelter Management Committees have been constituted by State/ULB to supervise the day-to-day functioning of the Shelter.
- (d)&(e): It is the primary responsibility of Governments of the States/ UTs to provide shelter for the urban homeless. However, in order to complement their efforts, Ministry of Housing and Urban Affairs is administering a scheme SUH under DAY-NULM, through respective States/UTs. PSC constituted at the State level is competent to consider and approve proposals for construction/refurbishment of shelters for urban homeless. The same committee is also empowered to sanction appropriate operations & management (O&M) cost of the shelters. The O&M cost, as approved by the PSC, would cover, *inter-alia*, the annual servicing cost which includes cost of upkeep, maintenance, replenishment of bedding and kitchen equipment etc.

Further, State Level Shelter Monitoring Committee constituted as per the direction of Hon'ble Supreme Court, Executive Committees at State and ULB level and Shelter Management Committees are constituted to take measures to improve the quality and required capacity of shelter homes under the said scheme.
