STATUS OF NEWLY DECLARED NH

356. SHRI VIJAY PAL SINGH TOMAR:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:

- (a) the details and the present status of the highways that have been declared as National Highways (NHs) along with the NHs which are under construction at present in the various States including Uttar Pradesh;
- (b) the details of new NH projects sanctioned for the State of Uttar Pradesh during the last three years and the current year; and
- (c) the action taken by Government to complete these projects in various States?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS (SHRI NITIN JAIRAM GADKARI)

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF RAJYA SABHA STARRED QUESTION NO. 356 ANSWERED ON 05.04.2023 ASKED BY SHRI VIJAY PAL SINGH TOMAR REGARDING STATUS OF NEWLY DECLARED NH

(a) Total length of National Highways (NHs) in the country has increased from about 91,287 km in March, 2014 to about 1,45,155 km at present.

Development and maintenance of NHs is a continuous process. Works on notified NHs are taken up accordingly as per traffic density, condition of road, inter-se priority and availability of funds.

State / Union Territory (UT)-wise details of ongoing NHs projects, including for the State of Uttar Pradesh, at present are annexed.

- (b) NHs Projects in about 1,739 km length have been sanctioned for the State of Uttar Pradesh during the last three years and the current year for implementation through State Government and the project implementation units of the Ministry. Apart from this, National Highways Authority of India (NHAI) has awarded NHs projects in about 3,049 km length for the State of Uttar Pradesh during the last three years and the current year.
- (c) The Ministry monitors affect closely various issues that project, environment/forest/wildlife clearances, Road Over Bridge (ROB) & Road Under Bridge (RUB) issues, contractual issues, land acquisition, encroachment removal, law & order issues, utility shifting, etc., for all NHs projects in various States/UTs, including for the State of Uttar Pradesh. Progress of projects is monitored through advanced digital platforms such as Project Monitoring Information System (PMIS) and Data Lake, Bhoomi Rashi portal (for Land Acquisition). Periodic reviews are held at various levels in the Ministry with all stakeholders including officers of executing agencies (such as National Highways Authority of India (NHAI), National Highways & Infrastructure Development Corporation Ltd. (NHIDCL), Border Roads Organization (BRO), State / UT Governments) to resolve these issues and ensure timely implementation of projects.
