(a) & (b) Since August 2019, Government of India in partnership with States is implementing Jal Jeevan Mission (JJM) – Har Ghar Jal to make provision of potable water to every rural household of the country by 2024, including those in Chhattisgarh, Jharkhand and Odisha, through tap water connection. Details of rural households and households with tap water connections in these States are as under:
