STATEMENT REFERRED IN REPLY TO RAJYA SABHA STARRED QUESTION NO. 38 FOR 06.02.2023 REGARDING 'RELEASE OF FUNDS UNDER PMAY-U FOR HIMACHAL PRADESH'

- (a) & (b):Ministry of Housing and Urban Affairs (MoHUA) is implementing Pradhan Mantri Awas Yojana-Urban (PMAY-U) since 25.06.2015 to provide pucca house with basic amenities to all eligible urban beneficiaries across the country. The scheme is implemented through four verticals i.e., Beneficiary Led Construction (BLC), Affordable Housing in Partnership (AHP), In-Situ Slum Redevelopment (ISSR) and Credit Linked Subsidy Scheme (CLSS) based on eligibility criteria as per scheme guidelines. Against the validated demand of 1.12 crore houses, as on 31.03.2022, 122.69 lakh houses were sanctioned,out of which more than 1.07 crore have been grounded and 68.02 lakh have been completed/delivered to the beneficiaries. The details of funds sanctioned and year-wise released to the all States/Union Territories (UTs) including Himachal Pradesh under the PMAY-U since 2020 is at Annexure-I.
- (c) & (d): The district-wise details of houses sanctioned, grounded for construction and completed alongwith number of projects sanctioned under PMAY-U in Himachal Pradesh since 2020 is at Annexure-II.
