#### IMPROPER STORAGE FACILITY

#### 1040 SHRI NEERAJ SHEKHAR:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) the details of volume of grain stocks, including wheat stock, which were kept in open and covered and plinth facilities in the country during 2021-22 and 2022-23, year-wise, State-wise and grain-wise;
- (b) the details of volume of wheat and other grains rotten during 2021-22 and 2022-23 till date due to lack of/improper storage facilities in the country, State-wise; and
- (c) the details of warehousing and cold storage facilities augmented during 2022-23 till 31 January, 2023, State-wise?

## A N S W E R MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

- (a): The details of wheat Stock stored in Cover & plinth (CAP) as on 1st of each month of financial Year 2021-22 to 01.04.2022 01.01.2023 is Annexed. Very negligible quantity of wheat is available in transit storage (CAP). A decision has already been taken to completely phase out the transit storage (CAP) of wheat stocks.
- (b): No foodgrains got rotten due to lack of/improper storage facilities in Food Corporation of India (FCI) during the year during 2021-22 and 2022-23.

- (c): FCI mainly stores Wheat & Rice after procurement for Public Distribution System (PDS) operation and to maintain buffer stocks which do not require temperature controlled warehouses. Further, FCI continuously assesses and monitors the storage capacity and based on the storage gap assessment, storage capacities are created/hired through the following schemes:-
  - 1. Construction of Silos under PPP mode.
  - 2. Private Entrepreneurs Guarantee (PEG).
  - 3. Central Sector scheme (CSS)
  - 4. Hiring of godown from Central Warehousing Corporation/ State Warehousing Corporations (SWCs)/State Agencies.
  - 5. Private Warehousing Scheme (PWS).

The Details of storage capacity augmented by FCI during 2022-23 till 31, January, 2023 are as given below:-

Besides work of creation of 34.875 LMT Hub & Spoke silos has been awarded in the month of January, 2023 in PPP mode

Further, Ministry of Food Processing Industries (MoFPI) does not support setting up of standalone warehousing and Cold Storage facilities. However, it incentivizes creation of preservation infrastructure as an integral part of food processing projects under relevant component schemes of Central Sector Pradhan Mantri Kisan SAMPADA Yojana (PMKSY). Under its component schemes, MoFPI mostly provides credit linked financial assistance (capital subsidy) in the form of grants-in-aid to entrepreneurs across the country. The details of approved projects under component schemes of PMKSY upto 31.12.2022 are as under:
