# APPROVAL TO AGRO PROCESSING CLUSTERS

#### 1076. SHRI MITHLESH KUMAR:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

(a) whether the Government has approved Agro Processing Clusters (APCs) in various states of the country, if so, the details thereof, State-wise and the number of clusters that have been approved in the State of Uttar Pradesh;

(b) whether adequate financial assistance has been provided to these clusters;

(c) if so, the details thereof and by when they would start functioning?

# ANSWER

# THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

(a) Yes, the Ministry of Food Processing Industries (MoFPI) has been implementing a sub-scheme – "Creation of Infrastructure for Agro Processing Cluster" (APC scheme) under an umbrella scheme – Pradhan Mantri Kisan Sampada Yojana (PMKSY) since 2017-18 across the country. As on 31.01.2023, under APC scheme, three (3) agro processing cluster projects have been approved in the State of Uttar Pradesh. State-wise number of projects approved under APC scheme is provided at **Annexure**.

(b) & (c): Financial assistance in the form of grants-in-aid up to a maximum amount of Rs. 10.00 crore per project is provided for implementation of agro processing cluster projects as per the extant APC scheme guidelines and the approval letter issued to the project implementing agency (PIA) of the project. The timeline for completion and operationalization of APC projects is 24 months from the date of issue of approval letter for the projects in general areas and 30 months for the projects in difficult areas.
