- (a) amount of total revenue from the commercial use of the railway stations;
- (b) names of top ten railway stations in terms of generating revenues;
- (c) whether Government will form an expert committee to examine the viability to generate revenues from stations all over the country;
- (d) whether it is a fact that revenue generation from New Delhi stations is less than what is expected; and
- (e) steps which are being taken to rationalise the revenue generation from stations?

- (a) The total revenue of the Indian Railways during FY 2021-22 and 2022-23 (upto Dec-22) is ₹1,91,278.30 crore and ₹1,74,441.34 crore respectively.
- (b) The top ten railway stations in terms of passengers revenue for FY 2021-22 and 2022-23 (upto Dec-2022) is as under:

- (c) and (d) No, Sir. No such committee has been contemplated. While Station wise targets are not set, passenger revenue at New Delhi railway station has seen a growth of 56.32% during FY 2021-22 viz a viz previous year (FY 2020-21). Total passenger revenue for New Delhi Railway Station to end of December-2022 is ₹ 2239.29 crore.
- (e) Steps are taken for rationalization of revenues which is a continuous exercise and is done through various means including, rationalization of fares & freight, monitoring of the passenger waitlist for attachment of additional coaches, operating special or new trains etc. To enhance freight revenue, Indian Railways is constantly in touch with customers. Its focus is on meeting the needs of freight in terms of timely availability, reliable service and proper handling of cargo.
