Development work done through CSR fund

1146 # Shri Aditya Prasad:

Will the Minister of *Coal* be pleased to state:

- (a) the details of the development works done by coal PSUs through Corporate Social Responsibility (CSR) fund in the State of Jharkhand;
- (b) the details of funds received and utilized from the coal PSUs for the said projects during last three years and the current year;
- (c) the status of actual progress of such development works/activities; and
- (d) whether the coal PSUs spend CSR funds in other areas instead of related projects areas, if so, the reasons therefor and remedial measures taken by Government in this regard?

ANSWER

(a) to (c): Details of CSR activities undertaken by concerned Coal PSUs in the state of Jharkhand are as follows:

Coal India Limited (CIL)- In the last 3 Financial Years from 2019-20 onward and current Financial Year (upto January,2023), CIL and its subsidiaries have undertaken more than 850 CSR activities in the state of Jharkhand. The details of major development works of project outlay of Rs. 1.00 crore or more are furnished in **Annex-I**.

Neyveli Lignite Corporation Limited (NLCIL) The developmental works as a part of Community Development Activities are being carried out and expenditure incurred from CSR fund of Ghatampur Thermal Power Plant, NUPPL. The details of fund received and utilised in last 3 year for Community Development Activities in Jharkhand (at project area of Pachwara South Coal Block/NUPPL) are furnished at **Annex-II**.

(d): As per CSR policy of CIL, subsidiaries of CIL spend at least 80% of their CSR funds every year within a radius of 25 kms. of their Project Sites/Mines/Area HQ/Company HQ and rest 20% within the States in which they are operating. CIL (HQ) being the holding company executes CSR activities in whole of India including the areas under subsidiary companies. Hence, priority is accorded to local areas in CSR spending as mandated in Section 135 of Companies Act 2013.

As per the CSR policy of Singareni Collieries Company Limited (SCCL), a substantial portion of CSR Budget i.e., to the extent of 80% shall be spent on CSR activities in the districts of Telangana, Odisha and other States where the SCCL is having coal mining and power and other business projects, 20% may be spent outside the aforesaid Areas. However, contribution to State/National level funds like State Disaster Management Authority Fund, PMRF and PM CARES Fund will not come in the purview of above geographical restriction. Accordingly the CSR activities are being taken up by SCCL.

NLCIL spends CSR funds for carrying out CSR activities / programmes / projects in the areas as per its CSR Policy (ie at least 75% of the CSR fund for local areas within 25 km and the remaining 25% within the state of the project or anywhere in the country), formulated in accordance with Companies Act 2013, prescribed by Ministry of Corporate Affairs, focusing on the socio economic development of the operating regions of NLCIL for achieving inclusive growth.
