**JAL JEEVAN MISSION (URBAN) IN PUNJAB**

**NO. 1152.                    SHRI RAGHAV CHADHA:**

**Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:**

- (a) the details of works done under Jal Jeevan Mission (Urban) in the State of Punjab during the last two years, district-wise;
- (b) the details of funds sanctioned, allocated and spent for these works during the last two years and the current year; and
- (c) the number of houses in which tap water has been supplied and the number of houses that are still left out under the said mission in Punjab, district-wise?

**ANSWER**

(a): The proposed Jal Jeevan Mission (Urban) scheme has been launched as Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0 on 01 October 2021 for a period of 05 years i.e. from the financial year 2021-22 to 2025-26. The mission aims at making the cities 'water secure' and provide universal coverage of water supply through functional taps to all households in all the statutory towns in the country. Mission also aims at providing sewage/ septage management to all households of 500 cities covered in first phase of the AMRUT scheme.

For the State of Punjab, ₹1,836 crore has been allocated as Central Assistance for implementation of projects under AMRUT 2.0. So far, Tranche-1 of the State Water Action Plan (SWAP) comprising 96 projects costing ₹2,840.90 crore, including committed Central Assistance (CA) of ₹1,261.80 crore have been approved for the State of Punjab in August, 2022 and ₹252.36 crore has been released as 1<sup>st</sup> instalment (20%) of eligible CA. Of these 96 projects, State Government has proposed 91 projects costing ₹2,380.90 crore in the Water Supply sector and 5 projects costing ₹460 crore in the Sewerage & Septage Management sector.

Further, Special tranche of SWAP under Mission Amrit Sarovar for rejuvenation of water bodies have also been approved for the State of Punjab in August, 2022 for 8 projects costing ₹32.51 crore, including committed CA of ₹11.67 crore and ₹2.33 crore has been released as 1<sup>st</sup> instalment (20%) of eligible CA against these projects.

(b): Under AMRUT 2.0, Central funds for the States/ Union Territories have been sanctioned/ allocated for the entire Mission period and not year-wise. For the State of Punjab, Central Assistance of ₹1,836 crore has been allocated for the entire Mission period towards implementation of projects to be taken up under AMRUT 2.0. Apart from this, an amount of ₹59.67 crore has also been allocated towards Administrative & Other Expenses (A&OE) for the entire Mission period.

The details of Central funds released to the State of Punjab so far under AMRUT 2.0 in the last two financial years and the current year is as under:
