STREETS FOR PEOPLE CHALLENGE

NO. 1335. DR. KANIMOZHI NVN SOMU:

Will the Minister of *Housing and Urban Affairs* be pleased to state:

- (a) whether Government has organized an online event where it announced eleven winning cities for the 'Streets for People Challenge' and ten winning cities for the pilot stage of the 'nurturing neighbourhoods challenge';
- (b) if so, the details thereof and the criteria fixed by Government for choosing such cities;
- (c) whether Government proposes to provide any financial assistance to cities which performed better in 'Streets for People Challenge'; and
- (d) if so, the details thereof and to what extent?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a) to (d) : Yes, Sir. The Government organized an online event on January 17 2022 to announce eleven winning cities under the 'Streets4People Challenge' and ten winning cities for the pilot stage of the 'Nurturing Neighborhoods Challenge'. The criteria for selection of cities under the 'Streets4People Challenge' and 'Nurturing Neighborhoods Challenge' is given in Annexure-I. An incentive of \gtrless 50 lakh per city for the top 11 cities has been provided under the 'Streets4People Challenge'.

Annexure-I in reply to Parts (a) to (d) of Rajya Sabha Unstarred Question No. 1335 for answer on 13.03.2023 regarding Streets for people challenge asked by Dr. Kanimozhi NVN Somu, Hon'ble MP.

A. Evaluation criteria for Streets4People Challenge

(a) Qualification Criteria - A city was considered eligible for the evaluation only if it cleared the qualification criteria listed below:

- 1. **Pilot Intervention**
- 2. Scale-up strategy
- 3. **Building support**

Evaluation - A reputed panel of national and international experts were identified to review the submissions of the eligible cities to shortlist the top 11 cities. The cities were evaluated based on their progress and quality of work in the areas listed below:

- 1. Quality and impact of the pilot intervention
- 2. Scale-up strategy
- **3.** Building support for cycling

B. Evaluation criteria for Nurturing Neighborhoods Challenge

A reputed panel of national and international experts were identified to review the submissions of the cities to shortlist the top 10 cities. The evaluation criteria is listed below.
