KHADI GRAMODYOG SCHEMES IN MAHARASHTRA

1381. SHRI DHANANJAY BHIMRAO MAHADIK:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the schemes being run by Khadi Gramodyog in the State of Maharashtra during the last three years;
- (b) the quantum of allocated funds for the said schemes; and
- (c) the details of number of beneficiaries along with the status of the schemes expansion at present, district-wise?

ANSWER

(a): Ministry of MSME, through Khadi and Village Industries Commission (KVIC) is implementing the following schemes for employment generation:

I. Khadi Gramodyog Vikas Yojana (KGVY) has the following two components:

- i) **Khadi Vikas Yojana (KVVY)**- the components of KVVY are (i) Modified Market Development Assistance (MMDA), (ii) Interest Subsidy Eligibility Certificate Scheme (ISEC), (iii) Workshed Scheme for Khadi Artisans, (iv) Strengthening Infrastructure of Existing Weak Khadi Institutions and Assistance for Marketing Infrastructure and (v) Centre of Excellence for Khadi (CoEK).
- ii) **Gramodyog Vikas Yojana (GVY)**- the components of GVY are: (i) Agarbatti Programme, (ii) Leather Footwear Activity, (iii) Kumbhar Sashaktikaran Programme/ Pottery Programme, (iv) Beekeeping Activity/ Honey Mission Programme, (v) Waste Wood/Turn Wood Craft/ Wooden Toy /Products of Panchgavya, (vi) Hand Made Paper and Fiber related activities, (vii) Agro-Based Food Processing Industries and (viii) Service Industry.

II. Prime Minister's Employment Generation Programme (PMEGP), is a major credit-linked subsidy programme, aimed at generating self-employment opportunities for the rural and urban unemployed persons through establishment of micro-enterprises in non-farm sector, in the country. Under PMEGP, General Category beneficiaries can avail benefit of Margin Money (MM) subsidy of 25% of the project cost in rural areas and 15% in urban areas. For beneficiaries belonging to Special Categories such as ST/SC/OBC/women/minorities/transgenders, etc. the MM subsidy is 35% in rural areas and 25% in urban areas. Beneficiary contribution is 10% (General Category) and 5% (Special Category). The maximum project cost is Rs. 50 lakh in the manufacturing sector and Rs. 20 lakh in the service sector.
