ANSWER

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) & (b): The Ministry of Tourism has provided financial assistance to the States/UTs under the 'Swadesh Darshan' & 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' Schemes for the development of tourism related infrastructure.

The Ministry of Tourism has also sanctioned projects under the 'Assistance to Central Agencies for Tourism Infrastructure Development' Scheme for the development of tourism related infrastructure in the States/UTs.

In addition, financial assistance has been provided to the States/UTs for organizing fairs/festivals & tourism related events under Domestic Promotion & Publicity including Hospitality (DPPH) Scheme.

The details of projects sanctioned in the States/UTs under the above mentioned schemes is given at **Annexure**.
