#### FUNDS FOR CAPITAL INTENSIVE PROJECTS

1472. SHRI G.V.L. NARASIMHA RAO:

Will the Minister of FINANCE be pleased to state:

- (a) the allocation and utilisation of the ₹1 lakh crore 50 years interest-free loans for capital investments announced in 2022-23 budget, State-wise;
- (b) the details of the loans sanctioned to different States by type of capital intensive projects proposed with this loan facility;
- (c) the list of projects and complete details of such projects for which Government of Andhra Pradesh has sought and availed this long term loan facility;
- (d) the mechanism for assessing suitability of the proposed projects, their proper implementation and ensuring that these funds are not diverted for other purposes; and
- (e) the action contemplated in case of diversion of funds?

### **ANSWER**

## THE MINISTER OF STATE FOR FINANCE (SHRI PANKAJ CHAUDHARY)

- (a) to (b): The Department of Expenditure, Ministry of Finance is providing 50-year interest free loan to States under the 'Scheme for Special Assistance to States for Capital Investment for 2022-23'. Out of the total budgetary allocation of Rs. 1 lakh crore for 2022-23, Rs. 80,000 crore (untied) under Part-I and Rs. 4,997 crore under Part-II of the Scheme (PM Gati Shakti related expenditure) have been allocated to States in proportion to their share of Tax Devolution for 2022-23. The rest of the amount is available to States based on meeting certain reform criteria. In case of Part-IV (Incentives for Digitisation), Part-V (Optical Fibre Cable), Part-VI (Urban Reforms) and Part-VIII (Incentives for Scrapping Old Vehicles), States have been divided into groups with different ceiling for maximum amount admissible on completion of reforms. Under Part-III (Supplemental Funding for Priority Segments of PMGSY including States' Share of PMGSY), Part-VI (Urban Reforms), Part-VII (Disinvestment of State Public Sector Enterprises (SPSEs) & Asset Monetization) and Part-VIII (Incentives for Scrapping Old Vehicles), incentives can be availed by States on Firstcome First-served basis. However, there is no difference in eligibility criteria for different Parts. The State-wise approved and released amount under various Parts of the Scheme is provided in Annexure-I.
- (c): The State Government of Andhra Pradesh has submitted an application under Part-I of the 'Scheme for Special Assistance to States for Capital Investment for 2022-23' and has

availed 50-year interest free loan amounting to Rs. 3,238.00 crore for the capital projects provided in Annexure-II. Similarly, the State Government of Andhra Pradesh has also submitted applications under Part-II and Part-V of the Scheme and has availed 50-year interest free loan amounting to Rs. 202.00 crore and Rs. 126.00 crore respectively for the capital projects provided in Annexure-III and Annexure-IV respectively.

- (d) and (e): The scheme guidelines on 'Scheme for Special Assistance to States for Capital Investment for 2022-23' includes mandatory conditions in addition to conditions applicable to each Part of the 'Scheme for Special Assistance to States for Capital Investment for 2022-23'. Further, release of 50-year interest free loan to States including the State of Andhra Pradesh is subject to following conditions:
  - i. The amount released by the Union Government shall be released to the Implementing Agencies of the State Government within 10 working days.
- ii. The amount released shall be utilized by 31.03.2023.
- iii. The State Government shall ensure that there is no duplication in funding of the capital projects approved under the Scheme either with the funds provided by the Government of India or the State Government.
- iv. In case of unavoidable changes in the specific project for which funds are being released, the State Government shall seek the approval of the Government of India for the change. Funds will not be provided in case of un-approved changes.
- v. Expenditure by the State of the funds provided under the Scheme, for purposes other than for which the funds were sanctioned, will result in the deduction of the amounts by the Government of India from the devolution of the taxes to the State.
- vi. All provisions of the guidelines of the Scheme issued vide letters no. 44(1)/PF-S/2022-23 (CAPEX) dated 06.04.2022, 06.07.2022 and 16.12.2022 shall be applicable in toto and shall be strictly adhered to by State Government and its implementing agencies.
- vii. Violations of mandatory conditions of the Scheme guidelines issued vide letter no. 44 (1)/PF-S/2022-23(CAPEX) dated 06.04.2022, will result in the deduction of amounts by the Government of India from devolution of taxes to the State.
