RETRENCHMENT OF EMPLOYEES IN LAKSHADWEEP

1653 DR. JOHN BRITTAS:

Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that thousands of employees, regular and/or contractual basis, have been retrenched from various departments, etc. under the UT Administration of Lakshadweep during the last three years;

(b) if so, number and details of native employees so retrenched /terminated from services / declined to get renewed the contract service during the last three years; and

(c) year-wise, category-wise and department-wise details thereof?

(a) As informed by UT Administration of Lakshadweep, staff requirement in the UT was reassessed as part of an exercise of administrative reforms and streamlining of the administrative machinery for efficient functioning of the administration. As per the re-assessment, surplus staff under regular and contractual categories was rightsized in various departments of the UT Administration.

(b) & (c) During the last three years, 25 regular employees were terminated from service on account of closing of unit, proceeding under FR 56(j) etc., and 911 contractual employees were disengaged/contract renewal was declined. Year-wise, category-wise and department-wise details are at Annexure 'A'.
