**INCREASED EMPLOYMENT IN ORGANIZED SECTOR**

**1857. SHRI NARHARI AMIN :**

**Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:**

- (a) whether there has been an increase in employment opportunities in the organized sector;**
- (b) if so, whether it has resulted into an increase in Employees' Provident Fund Organization (EPFO) registrations; and**
- (c) if so, the percentage-wise increase in EPFO registrations in the country during the last two years, the State-wise details thereof, particularly for Gujarat?**

**(a) to (c): The data on Employment and Unemployment is collected through Periodic Labour Force Survey (PLFS) which is conducted by the Ministry of Statistics and Programme Implementation (MoSPI) since 2017-18. The survey period is July to June of next year. As per the latest available Annual PLFS Reports, the estimated Worker Population Ratio (WPR) on usual status for persons of age 15 years and above during 2019-20 to 2021-22 is as follows:**

**The PLFS data indicates that the employment has increasing trend in the country.**

**Employees' Provident Fund Organization (EPFO) is publishing its monthly Payroll Data since Sept, 2017. The net addition in EPF subscribers in the country was 77.1 lakh and 122.3 lakh during 2020-21 and 2021-22, respectively, registering a growth of 59%. In Gujarat, the net addition in EPF subscribers was 7.5 lakh and 10.7 lakh during 2020-21 and 2021-22, respectively, registering a growth of 42%.**
