CROP LOANS TO GROSS VALUE OUTPUT FOR STATES

1944. DR RADHA MOHAN DAS AGRAWAL:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) the details of crop loans received by various States of the country and their gross value output during the last three years;
- (b) whether the credit received by some States is much higher than their gross agricultural output; and
- (c) whether Government has conducted any inquiry in this regard, if so, the Report thereof and if not, the reasons therefor?

(a): The details of crop loans received by various States of the country and their gross value output during the last three years is given at Annexure-I and II.

(b) & (c): The report of the Internal Working Group to review agriculture credit (RBI, 2019) highlighted regional disparity in getting agri-credit. To address regional disparities in the flow of priority sector, revised Priority Sector Lending (PSL) guidelines were issued on September 4, 2020. As the revised PSL guidelines, from FY 2021-22 onwards, a higher weight (125%) is assigned to the incremental priority sector credit in the identified districts where the credit flow is comparatively lower (per capita PSL less than Rs. 6000) and a lower weight (90%) is assigned for incremental priority sector credit in the identified districts where the credit flow is comparatively higher (per capita PSL greater than Rs. 25000).
