EXPORT OF FRUITS AND VEGETABLES

1968. SHRI DHANANJAY BHIMRAO MAHADIK:

Will the Minister of **COMMERCE & INDUSTRY** be pleased to state:

- (a) whether India has emerged as one of the largest exporter of fruits and vegetables;
- (b) if so, the details thereof, along with the details of fruits and vegetable exports from the country especially Maharashtra during the last three years and the current year;
- (c) whether Government has any data of area-specific production of fruits exported particularly from Maharashtra and if so, the details thereof, along with the measures taken to enhance the export of fruits and vegetables from the country; and
- (d) the other steps taken by Government to boost the export of fruits and vegetables?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SMT. ANUPRIYA PATEL)

- (a): India has a huge domestic consumption base for agriculture products, due to our large population base. However, exports of fresh fruits and vegetables from India have registered a growth of 19.03% in last three years i.e from USD 1421.93 million in 2019-20 to USD 1692.48 million in 2021-22. During the current financial year (Apr-Jan), exports have grown further by 5.04%, from USD 1220.21 during 2021-22 (Apr Jan) to USD 1281.70 million in 2022-23 (Apr-Jan).
- **(b):** The details of fresh fruits and fresh vegetables exports from the country and from Maharashtra during the last three years and the current year are as below:
