### INDUSTRIAL DEVELOPMENT CENTERS

#### 1978 SHRI NEERAJ DANGI:

Will the Minister of **Commerce and Industry** be pleased to state:

- (a) the details of Industrial Development Centers in the country at present, and whether Government proposes to set up more Industrial Development Centers in the country;
- (b) if so, the details thereof, place-wise and State-wise;
- (c) the sector-wise details of exports and imports of the Industrial Sector of the country for each of the last three years, and the details of their share in Gross Domestic Product; and
- (d) the details of the concrete steps taken by Government to improve industrial production and development?

#### **ANSWER**

## THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE & INDUSTRY (SHRI SOM PARKASH)

(a) & (b): The Department for Promotion of Industry & Internal Trade has supported Industrial Development Centres through 'Industrial Infrastructure Upgradation Scheme (IIUS)/Modified IIUS (MIIUS)'. The scheme has been discontinued from 31st March, 2017 for taking up new projects. A state-wise detailed list of the 58 projects sanctioned under the scheme is annexed (*Annexure-I*).

Department is developing Industrial Corridor Projects in four phases as part of the National Industrial Corridor programme, which aims to develop futuristic industrial regions/nodes/areas in India that can compete with the best manufacturing and investment destinations in the world. The programme aims to provide multi-modal infrastructure connectivity to the economic nodes, while building internal trunk infrastructure, alongwith common infrastructure utilities, including 'plugand-play' facilities.

In following four such economic nodes/projects, a total of 227 plots, measuring nearly 1197 acres, have been allocated to companies:

- i. Industrial Township (IITGN) at Greater Noida, Uttar Pradesh
- ii. Integrated Industrial Township (IITVUL) at Vikram Udyogpuri, Ujjain in Madhya Pradesh
- iii. Dholera Special Investment Region (DSIR), Gujarat
- iv. Shendra Bidkin Industrial Area (AURIC), Aurangabad

In another four economic nodes/projects, work is at implementation stage:

- i. Integrated Multi-Modal Logistics Hub Nangal Chaudhary, Harvana
- ii. Multi Modal Logistics Hub & Multi Modal Transport Hub (MMLH & MMTH), Greater Noida, Uttar Pradesh
- iii. Krishnapatnam Industrial Area, Andhra Pradesh
- iv. Tumakuru Industrial Area, Karnataka
- (c): The details of exports and imports of merchandise goods and their share in Gross Domestic Product for last three years from 2019-20 to 2021-22 are as under:

(d): Government has undertaken various steps to boost industrial production and development including introduction of Goods and Services Tax, reduction in Corporate tax, interventions to improve ease of doing business, measures for reduction in compliance burden, policy measures to boost domestic manufacturing through public procurement orders, Phased Manufacturing Programme (PMP), FDI policy reforms, Production Linked Incentive Schemes. Government has also focused on infrastructure development through creation of investment opportunities under National Infrastructure Pipeline (NIP) and National Monetisation Pipeline (NMP), putting in-place National Single Window System (NSWS). PM Gati Shakti-National Master Plan & Logistics Policy is implemented to facilitate development of infrastructure and last mile connectivity for reduction in logistic cost and increase the efficiency of economy.
