Will the Minister of ELECTRONICS AND INFORMATION TECHNOLOGY be pleased to state:

- (a) the details of training programmes conducted since 2019 for network administrators and Chief Information Security Officers of Government organisations to ensure the security of IT infrastructure, year-wise;
- (b) the categories and priority levels of Government organisations that are given support to maintain the security of IT infrastructure, year-wise; and
- (c) the details of funds allocated towards securing Government IT infrastructure since 2019, year-wise?

ANSWER

MINISTER OF STATE FOR ELECTRONICS AND INFORMATION TECHNOLOGY (SHRI RAJEEV CHANDRASEKHAR)

(a): The year-wise details of training programmes conducted to train, among others, Chief Information Security Officers (CISOs) and other officials of the Central Government, State Governments and government organisations, on matters relating to ensure the security of information technology (IT) infrastructure, are at Annex.

(b) and (c):IT infrastructure is set up and maintained by various Ministries, Departments and organisations of the government from their respective budgets, as per their priorities. Security aspects are integral to the design, architecture and maintenance of such infrastructure. As such, expenditure on securing government IT infrastructure and its maintenance is subsumed within the overall integrated cost of each IT project and is not separately identifiable.
