**MSMEs IN THE STATE OF TAMIL NADU**

2182. SHRI TIRUCHI SIVA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether the Udyam Registration Portal has classified and registered the Micro, Small, and Medium Enterprises (MSMEs) functioning at present in Tamil Nadu particularly and if so, the details thereof;
- (b) the details of the MSMEs that have been set up in Tamil Nadu during the last four years under various schemes;
- (c) the number of enterprises set up in Tamil Nadu after the introduction of the MUDRA scheme; and
- (d) the details about the loan disbursed to the said enterprises under the Pradhan Mantri Aatmanirbhar Bharat Abhiyan in the State of Tamil Nadu ?

**ANSWER**

(a): Since the launch of Udyam Registration Portal on 01.07.2020 till 15.03.2023, a total of 15,46,638 enterprises of Tamil Nadu have registered and have been classified on Udyam Registration Portal.

(b): As per the Udyam Registration Portal, the details of the MSMEs set up in the State of Tamil Nadu during the last four years are as below:

(c): As per information received from Department of Financial Services, Ministry of Finance, since inception of the Pradhan Mantri Mudra Yojana (PMMY) scheme in April 2015 till 13.03.2023, 4,56,31,509 number of loan accounts have been sanctioned with Rs. 2,20,765 crores in the State of Tamil Nadu.

(d): The Government has taken a number of initiatives under AatmaNirbhar Bharat to support MSMEs in the country, including the State of Tamil Nadu. Under Emergency Credit Line Guarantee Scheme (ECLGS), a total of 9,13,163 guarantees amounting to Rs. 39,926.38 crore has been provided to MSMEs in Tamil Nadu. Under the Self Reliant India Fund, 8 units from the State of Tamil Nadu have benefitted.
