## Reducing dependency on medical devices

## 2267 # Shri Neeraj Dangi:

## Will the Minister of **Chemicals and Fertilizers** be pleased to state:

(a) whether the country currently imports medical equipments, especially high-end equipments, if so, the details thereof;

(b) whether Government has any plan to promote domestic manufacturing of medical devices; (c) if so, the details of the amount allocated by Government for such scheme during the last two years and in the current year; and

(d) the details of the targets set by Government to reduce dependency of medical equipments?

## ANSWER

## MINISTER OF STATE IN THE MINISTRY OF CHEMICALS & FERTILIZERS (SHRI BHAGWANTH KHUBA)

(a): Yes Sir, the country currently imports medical equipment including high end equipment and the details of imports for last two FYs are given below:

(b) to (d): The Government of India has taken several measures to encourage domestic manufacturing of Medical Devices to reduce import dependence and to establish a dominant position in the global market. The Programmatic interventions to support Pharma Industries as on date are as follows:

i. *PLI Scheme for Promoting Domestic Manufacturing of Medical Devices* with total financial outlay of Rs. 3,420 crore and tenure from FY 2020-2021 to FY 2027-28, provides incentive to selected companies at the rate of 5% on incremental sales of

medical devices manufactured in India and covered under the four Target segments of the scheme, for a period of five (5) years. Under the scheme, a total of 60 applications (42 applications of Category-A and 18 applications of Category-B) have been received out of which, 26 applications have been approved, with a committed investment of Rs. 1,205.52 cr. As per the information submitted by the applicants on the sales for the period from April 2022 to December 2022, an investment of Rs.714 Cr has been reported. Fourteen projects have been commissioned so far. Under the scheme, domestic manufacturing of high-end medical devices has started which include Linear Accelerator, MRI Scan, CT-Scan, Mammogram, C-Arm, MRI Coils, high end X-ray tubes, etc and the details of the approved medical devices under the PLI scheme is attached at **Annexure.** 

- Production Linked Incentive Scheme for Pharmaceuticals, with a financial outlay Rs. 15,000 crores and the tenure from FY 2020- 2021 to FY 2028-29, provides for financial incentive to 55 selected applicants which also covers five (5) applicants under Group C category, to manufacture In-Vitro Diagnostic (IVD) medical devices. The incentive period under the scheme is for six years and a total 457 IVD products has been approved under the scheme.
- iii. The scheme *Promotion of Medical Devices Parks*, with a total financial outlay of Rs. 400 crore and the tenure from FY 2020-2021 to FY 2024-2025, provides for the maximum financial assistance of Rs. 100 crore each to 4 selected States/Union Territories for creation of Common Infrastructure Facilities in the upcoming Medical Devices Parks. Under the scheme, final approval for financial assistance of Rs. 100 crore each, has been given to the States of Uttar Pradesh, Tamil Nadu, Madhya Pradesh and Himachal Pradesh.
- iv. Under the major non-schematic intervention, in order to attract investments in Medical Devices sector, the Government has allowed 100% FDI under automatic route

FY 2022-23 is the first year of production for the above two PLI schemes. In FY 20-21 and FY 21-22, an amount of Rs.2.0 Cr and Rs.3.31 Cr had been allotted towards PMA charges under PLI scheme for Medical Devices; Similarly, an amount of Rs.3.0 Cr had been allocated under PLI scheme for Pharmaceuticals in FY 21-22 towards PMA Charges. In current FY of 22-23, an amount of Rs.21.56 Cr and Rs.694.2 Cr have been allocated for PLI scheme for Medical Devices respectively.

Under the Medical Devices Parks Scheme, Rs. 21.05 Cr and Rs.137.02 cr were allocated in FY 20-21 and FY 21-22 respectively and first instalment of Rs.30 Cr per park had been released in FY 21-22. In current FY 22-23, a provision of 0.9 Cr has been made towards PMA charges.
