Will the MINISTER OF HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that an estimated amount of almost 7.2 billion USD has been received by the country as an aid from International Financial Institutions including the World Bank, ADB, AIIB and NDB, during the course of the pandemic;
- (b) if so, State-wise break-up of budget and expenditure incurred on the specific heads committed under the grants including installing COVID beds, purchase of health equipment, establishing laboratories, other research/scientific activities and other activities;
- (c) the extent to which the delivery targets under the loans have been achieved; and
- (d) the plans for utilization of underspending, if any?
