- (a) the details of the funds allocated and released for the menstrual hygiene scheme since 2019, year-wise and State-wise;
- (b) the details of studies conducted by the Department of Health Research into the newer methods of managing menstrual health and other sustainable alternatives to sanitary napkins since 2019; and
- (c) the number of adolescent girls who have been benefitted under the Scheme since 2019 , year-wise and State-wise?

- (b) A recent study from ICMR has examined the user experience with menstrual cups, which are a sustainable alternative to sanitary pads. According to the study, menstrual cup is an effective and convenient sanitary product that has the potential to be used as an alternative method. However, it requires more awareness and promotion for wider adoption by

leveraging existing platforms. The study also recommended that future research should focus on the socio-cultural aspects of menstrual cup acceptance in rural India.
