PERFORMANCE OF PMAY-G PROGRAMME

2490 DR. SASMIT PATRA:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) details of the performance of the PMAY-G programme in the country during last five years in a Centre and State-wise manner in ensuring Housing for All in the country;
- (b) reason for shifting Housing for All target from 2022 to 2024;
- (c) whether Central Government would be willing to re-survey outside the Socio Economic Caste Census (SECC) list to include eligible beneficiaries for PMAY-G, especially those who were left out from the SECC list in 2011; and
- (d) when would the Housing for All in the country be completed?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

(a) The number of houses sanctioned and completed under Pradhan Mantri Awaas Yojana - Gramin (PMAY-G) during the last five years i.e. 2017-18 to 2021-22 are 2.21 crore and 1.77 crore respectively. The States/Union Territories (UTs) wise details of targets allocated, houses sanctioned and completed during last five years (FY 2017-18 to 2021-22) under PMAY-G is given in **Annexure**.

(b) During the period of Covid-19 pandemic induced nation-wide lockdown, all construction activities including construction of houses under PMAY-G were affected which retarded the pace of construction of PMAY- G houses. Besides, the delays are also due to delay in release of Central & State Share from State Treasury to State Nodal Account of PMAY-G, cases of unwillingness of beneficiaries, migration, disputed succession of deceased beneficiaries, delay in allotment of land to landless beneficiaries by the States/UTs, at times General/ Assembly/ Panchayat elections, and unavailability of building materials. Therefore, the timeline for completion of 2.95 crore houses under PMAY-G has been extended from March, 2022 to March, 2024.

(c) In order to capture the details of the households though eligible under PMAY-G but not included in PMAY-G, the Ministry through States/ UTs carried out the Awaas+ survey during January 2018- March 2019. At present, there is no proposal to carry out the survey again.

(d) As per the approval of Union Cabinet, the deadline for completion of 2.95 crore houses under PMAY-G is March, 2024.
