Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) the number of beneficiaries in the country who have been provided ration free of cost by Government since the Corona period till date, the details thereof, State-wise;
- (b) total financial expenditure that has been incurred by the Central Government till date for the said purpose; and
- (c) total financial expenditure estimated to be incurred under this scheme in future?

A N S W E R MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

- (a): All 80 Crore (approximately) Antyodaya Anna Yojana (AAY) & Priority Household (PHH) beneficiaries are entitled for free-of-cost ration under PM-GKAY. State-wise list of beneficiaries is attached at **Annexure-I.**
- (b)&(c): Under Pradhan Mantri Garib Kalyan Anna Yojana (PM-GKAY), about 1118 LMT foodgrains with an earmarked financial outlay of approximately Rs. 3.91 Lakh Crore has been provisioned, out of which an amount of around Rs. 3.47 Lakh Crore (including transportation & dealer margin etc) has been incurred till date for the said purpose. The scheme has been implemented in 7 phases for the duration of 28 months since April 2020 to December 2022, (Annexure-II).

Central Government has decided that the foodgrains shall be provided free of cost to all eligible Antyodaya Anna Yojana (AAY) & Priority Household (PHH) beneficiaries for the period 1st of January, 2023 to 31st of December, 2023. The Central Government will bear approximately an amount of Rs. 2 Lakh Crore as food subsidy.
