- (b) whether it is meant to fill the gap of PTI;
- (c) the details of its commercial income and expenditure since then;
- (d) the reasons as to why Hindusthan Samachar is engaged, if PBNS is successful;
- (e) the amount that has been paid to Hindusthan Samachar, year-wise, or whether it will be paid under the new arrangement; and
- (f) the amount paid by Prasar Bharati and Doordarshan to ANI for different purposes in the last five years?
