- (a) the steps taken and the schemes announced by Government to promote the setting up of food processing industries in the country and the details thereof;

### ANSWER

# THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

(a) & (b): The Ministry of Food Processing industries (MoFPI) has been implementing Central Sector Umbrella Scheme-Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) since 2016-17, Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) since 2021-22 and centrally sponsored PM Formalisation of Micro Food Processing Enterprises Scheme (PMFME) since 2020-21 and for overall growth and development of food processing sector across the country including to promote the setting up of food processing industries.

Under component schemes of PMKSY, MoFPI provides mostly credit linked financial assistance (capital subsidy) in the form of grants-in-aid to entrepreneurs for setting up of food processing / preservation industries. Ministry provides financial, technical and business support for setting up/upgradation of micro food processing enterprises under PMFME scheme. PLISFPI is targeted to facilitate expansion of food processing capacity by creating champion brands in Food Processing Sector. The state-wise number of approved & completed projects under PMKSY, number of loans sanctioned to Micro Food Enterprises & Incubation centres under PMFME Scheme are placed at **Annexure-I.** 

(c): The details of funds allocated and funds utilized utilized under PMKSY, PMFME and PLISFPI since 2018-19 are placed at **Annexure-II.**
