- (d) if so, the number of persons who have been provided employment?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF UNSTARRED QUESTION NO. 2847 BY SHRI. NARAIN DASS GUPTA ANSWERED IN RAJYA SABHA ON 24.03.2023 REGARDING RECRUITMENT IN VARIOUS CATEGORIES IN RAILWAYS

(a) The different modes of recruitment being carried out by Railways for various categories are recruitment from Open market, Compassionate Ground Appointment, Recruitment under Scouts and Guide and Cultural Quota and Recruitment against Sports Quota. Direct recruitment in Group 'A' Junior Scale on Indian Railways is mainly through Civil Service Examination (CSE) and Combined Medical Services Examination (CMSE) and others conducted by UPSC every year.

(b) The details of the recruitment advertisements published during the period of financial year 2019-20 till date is as under:

Apart from this, from 01-04-2019 till date, 27 notifications have been issued for recruitment under Scouts and Guide Quota and 21 notifications have been issued for recruitment under Cultural Quota. 55 notifications have been issued under Sports quota during the said period.

(c) Yes sir. However, it is mentioned that certain small scale recruitments under Scouts and Guide and Cultural Quota in the period of 2020-21 to 2021-22 have been cancelled due to Covid-19 Pandemic. However, the bigger recruitment drives mentioned above have been done.

Against Scouts and Guide Quota, Cultural Quota and Sports Quota, 183, 22 and 725 persons have been provided job respectively from 01-04-2019 till date. As against Direct Recruitment to Group A- Services, 921 vacancies were filled though UPSC during the said period.
