(b)&(c): When an employee (Executive & Non Executive) joins CIL, he/she is issued a Health Card along with his/her dependents which is valid till retirement. After retirement, retired employee is issued another CPRMS-E/NE card for the employee and his/her spouse which is valid for their life time. No renewal of the card is required.
