SMART CITIES MISSION IN MADHYA PRADESH

NO. 2955. SHRI VIVEK K. TANKHA:

Will the Minister of *Housing and Urban Affairs* be pleased to state:

- (a) the details of smart cities in the State of Madhya Pradesh, under Smart Cities Mission(SCM);
- (b) the details of funds allocated by Government to each city under the SCM;
- (c) whether Government is considering to include more cities from the State in the SCM; and
- (d) if so, the details thereof?

(a) to (d) : Government of India launched Smart Cities Mission (SCM) on 25 June 2015. 100 Smart Cities have been selected through 4 rounds of competition from January 2016 to June 2018. As per SCM Guidelines, Central Government will provide financial support to the extent of ₹ 48,000 crore over five years to the 100 Smart Cities i.e., on an average ₹ 100 crore per city per year. An equal amount on a matching basis will be contributed by the State Government/Urban Local Body (ULB).

In the State of Madhya Pradesh, the cities of Bhopal, Gwalior, Indore, Jabalpur, Sagar, Satna, and Ujjain were selected for development as Smart Cities.

As on 3 March 2023, Government of India has released ₹ 2,695 crore and State Government of Madhya Pradesh has released its matching share of ₹ 2,580 crore amounting to a total release of ₹ 5,275 crore, of which ₹ 4,974 crore (94%) has been utilized. The Smart City-wise details of funds released under SCM for Smart Cities in Madhya Pradesh and utilization thereof is given below:-
