**IMPLEMENTATION OF JAL JEEVAN MISSION IN NORTH EASTERN STATES**

**2963 SHRI BIPLAB KUMAR DEB:**

Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether a comprehensive programme is being implemented to provide safe and adequate drinking water through tap water connection to each household in the country;
- (b) the details of the funds allocated and spent under Jal Jeevan Mission during the last three years in the North Eastern States, year-wise, State-wise; and
- (c) the details of the connections sanctioned and connections provided to the households under the scheme during the last three years in North-Eastern States, year-wise, State wise?

**ANSWER**

**(SHRI PRAHLAD SINGH PATEL)**

(a) to (c) To enable every rural household in the country to have assured potable water in adequate quantity (55 liters per capita per day) of prescribed quality (BIS:10500) on regular and long-term basis, through tap water connection, Government of India in partnership with States is implementing Jal Jeevan Mission (JJM) - Har Ghar Jal since Aug., 2019.

Year-wise & State-wise details of Central fund allocated, fund drawn and fund utilization reported by the North Eastern States under Jal Jeevan Mission is at **Annex-I**.

At the time of announcement of Jal Jeevan Mission in August 2019, 2.83 lakh (3%) rural households were reported to have tap water connections in the North Eastern (NE) States. So far, as reported by NE States as on 22.03.2023, additional 45.34 lakh rural households have been provided with tap water connections in last three and half years under JJM. Thus, as on 22.03.2023, out of 94.42 lakh rural households in the NE States, around 48.17 lakh (51%) households are reported to have tap water supply in their homes. Year-wise, State-wise details are at **Annex-II**.
