FUNDS RELEASED TO SSIs

2987. SHRI KAMAKHYA PRASAD TASA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether Government has released funds for setting up Small Scale Industries (SSIs) under its ongoing scheme during the last two years;
- (b) if so, the details thereof and the total funds released by Government, State-wise, year-wise;
- (c) the total number of SSIs setup in various North Eastern States during the said period;
- (d) the details of the different units of Micro, Small and Medium Enterprises proposed to be set up in the State of Assam including present status thereof; and
- (e) whether Government has allocated land for setting up of all these units and if so, the details thereof, State-wise?

ANSWER

(a) & (b): Ministry of MSME, through Khadi and Village Industries Commission (KVIC), is implementing Prime Minister's Employment Generation Programme (PMEGP) for assisting entrepreneurs in setting up of new units in the non-farm sector across the country. It aims to provide employment opportunities to traditional artisans/ rural and urban unemployed youth at their doorstep.

Under PMEGP scheme, funds are not released to the States. Margin Money (Subsidy) is provided directly to the accounts of beneficiaries who are availing loans under PMEGP from banks for setting up new enterprises. General Category beneficiaries can avail of Margin Money (MM) subsidy of 25% of the project cost in rural areas and 15% in urban areas. For beneficiaries belonging to Special Categories such as Scheduled Castes, Scheduled Tribes, OBCs, Minorities, Women, Ex-servicemen, Differently-abled, Transgenders, beneficiaries belonging to Northeastern Region, Hill and Border areas, and Aspirational Districts, the Margin Money subsidy is 35% in rural areas and 25% in urban area. The maximum cost of project is Rs. 50 lakhs in the manufacturing sector and Rs. 20 lakhs in the service sector.
