\*Remarks of State Government:

Currently, there are 52 districts in Madhya Pradesh where DMF has been set up. Prior to Jan 2021, there were 22 districts with major minerals where DMF has been set up. However, one out of 22 districts (Alirajpur) has been excluded from the audit and annual report because the district has no active mines of major minerals for the DMF to be collected as in no fund to be audited. Even in the case of the Annual Report, the district has submitted the report with zero projects for the last three years. Therefore, Alirajpur has been removed from the list by the Government of Madhya Pradesh.
