## POWER PROJECTS IN UTTAR PRADESH

#### 3190 # SMT. KANTA KARDAM:

Will the Minister of **POWER** be pleased to state:

(a) the number of power projects running in Uttar Pradesh, the details thereof;

(b) the funds sanctioned, allocated and utilized under these projects during the last two years, the present status of these projects;

(c) whether some of these projects are facing huge cost/time overrun and if so, the details thereof; and

(d) the action taken/being taken by Government for timely completion of these projects?

# ANSWER

## THE MINISTER OF POWER AND NEW & RENEWABLE ENERGY

(SHRI R.K. SINGH)

(a) to (d): Presently, five power projects are under construction in the State of Uttar Pradesh. The details of funds sanctioned, allocated & utilized along with their present status are given at Annexure.

The following steps have been taken by the Government to ensure timely completion of Power Projects: -

- (i) The Central Electricity Authority (CEA) monitors the progress of under construction power projects through periodic review meetings, site visits and interaction with the developers & other stakeholders to identify and resolve issues critical for commissioning of Projects.
- (ii) Regular reviews are also undertaken in Ministry of Power (MoP) to identify the constraints and facilitate faster resolution of inter-ministerial and other outstanding issues.
- (iii) In case of Central Power Sector Undertakings (CPSU's) projects, the project implementation parameters / milestones are incorporated in the annual MoU signed between respective CPSU's and MoP and the same are monitored during the Quarterly Performance Review (QPR) meetings of CPSU's and other meetings held in MoP/ CEA.
- (iv) Various matters related with project implementation are being taken up with State Government/District Administration for expeditious resolution of issues.
