- (e) So far as status of construction of the new campus of IIM Visakhapatnam is concerned, Hostel, Dining & Classrooms buildings are completed and in operation and Library, Sports, Auditorium buildings are in finishing stage. GRIHA 5-star rating campus, with a net-zero status in energy, water and carbon footprint in the construction project is its key feature. The funds sanctioned are as per above reply to parts (a) to (d).
- (f) IIM Visakhapatnam is ranked 33 in NIRF rankings in Management Category in 2022.
- (g) IIM Visakhapatnam, through its incubation centre IIMV Foundation for Incubation Entrepreneurial Learning and Development (IIMV FIELD), has been leading initiatives for women empowerment and has supported 53 Women Led startups in its flagship programs so far.
- (h) IIMV FIELD is the Incubation and Startup Hub of IIM Visakhapatnam which aims to promote, develop, and nurture the culture of entrepreneurship and innovation by way of facilitating, enabling, creating, fostering, supporting, funding/investing, mentoring, managing the entrepreneurial efforts, initiatives, endeavours, and ventures. After the host institute, IIM Visakhapatnam started its operations in 2015, IIMV FIELD has been steadily making an impact in the ecosystem.
