# Setting up of women cells in higher educational institutions

3245 SHRI JAGGESH:

Will the Minister of EDUCATION be pleased to state:

(a) whether it is a fact that Government proposes to layout guidelines for Universities to ensure basic facilities and amenities for a secure environment for female students;

(b) whether Government proposes to recommend the setting up of women cells in higher educational institutions for sensitization and policy implementation, monitoring and grievance redressal;

(c) If so, details of the guidelines and other steps taken by Government to make college and University campus safer for women; and

(d) the details thereof?

#### ANSWER

### MINISTER OF STATE IN THE MINISTRY OF EDUCATION (DR. SUBHAS SARKAR)

(a) to (d): University Grants Commission (UGC) has developed the "Guidelines on basic facilities and amenities for safe, secure environment for Women and Women Cell (for sensitization, policy implementation, monitoring and grievance redressal) in Higher Educational Institutions (HEIs)" to provide a safe, secure and violence free environment to all the students particularly the women students.The guidelines are available on the UGC website at <u>www.ugc.gov.in</u>.

All HEIs have been mandated to have Internal Complaints Committee (ICC) under the provision of Section 4 of Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013. Advisories have been issued from time to time for taking action in order to sensitize the issue related to maintenance of safe working environment for female employees as per the Act. In order to improve the safety of all women, including students and employees, and to provide a healthy and secure atmosphere for them on the campus in Higher Educational Institutes (HEIs), following initiatives have been taken:-

i. UGC has notified UGC (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions) Regulations, 2015, which being statutory in nature, are binding on Universities and Colleges. This regulation is available on UGC website i.e. <u>www.ugc.gov.in</u>.

- ii. UGC has set up Toll free No. 1800-111-656 for registration of grievances related to Women and sexual harassment.
- iii. Seminars/ awareness workshops etc. are conducted for Gender Sensitization in HEIs. Recently, a special drive was also conducted in HEIs to observe the 25<sup>th</sup> November as the International Day for the Elimination of Violence against Women, to observe prevention of Discrimination against Women Pakhwada from 25<sup>th</sup> November to 10<sup>th</sup> December, 2022 and for ICCs to review the pending cases and take appropriate action thereon.
