SHARING OF USER FEE TOLL WITH STATES

3286. DR. JOHN BRITAS:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:

(a) total amount of user fee toll collected by Government from roads and bridges during last five years;

(b) year-wise and State-wise details thereof;

(c) whether Government agree to share the revenue generated from tolls with those State Governments which have shared the cost of road development by way of providing funds for land acquisition, etc.; and

(d) if not, the reasons therefor?

(a)&(b) The details of the user fee collection on National Highways year-wise and state-wise is enclosed at Annexure-I.

(c)&(d) Presently, Fee is being collected at fee plazas on National Highways as per National Highways Fee (Determination of Rates and Collection) Rules, 2008, and its amendments thereafter.

As per the provisions of the said rules, in case of public funded projects, the fee collected under the provisions of these rules by every executing authority shall be remitted to the Central Government. In case of private investment projects, the fee collected under the provision of these rules shall be appropriated by the concessionaire in accordance with the provisions of and for the performance of its obligations under the concession agreement entered into by such concessionaire.
