#### SURVEY OF NH FOR REPAIR WORK

3293. DR. C. M. RAMESH:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:

- (a) whether Government has made any survey of National Highways throughout the country where some stretches of road are in bad shape and require immediate remedial action for the benefit of road users, details thereof, State-wise; and
- (b) when such survey was last conducted and whether adequate manpower with expertise in this field is available for the purpose, details thereof?

#### ANSWER

# THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS (SHRI NITIN JAIRAM GADKARI)

(a) and (b) Development and maintenance of National Highways (NHs) is a continuous process. NHs are regularly inspected and based thereon, further investigations are carried out wherever required for assessment of repair/ rehabilitation needs of a particular section of NH. Manpower and equipment are usually deployed for such surveys and investigations, meeting the requirements of specifications/ guidelines laid down by Ministry of Road Transport and Highways/ Indian Road Congress. Allocations made for maintenance and repair (M&R) of National Highways during last three years and the current year, state-wise are annexed.
